**CRRSA:**

All CRRSAA awards were completed prior to this reporting quarter.

**ARP:**

- a. If a FAFSA had been submitted, initial student need was assessed by determining EFC, based on 2020 FAFSA or unpaid balance to the college that interfered with enrollment for fall 2021 semester. Other student need was identified through contact by student with the student services office.
- b. Students were invited to submit an online ARP Grant Form indicating additional needs in basic living expenses and technology and to add additional comments regarding their needs. A grants review committee reviewed student responses in which additional needs were identified and an awarding matrix determined.
- c. Students eligible for the ARP funding, defined as all matriculated students for Fall 2021 who submitted an ARP Grant form identifying an established or previously unaddressed need per the awarding matrix received funding.

**CRRSA:** All CRRSAA awards were completed prior to this reporting quarter; no further communications were made to students regarding this program.

**ARP:**

To assist you with some of the additional financial challenges that you may be facing due to the pandemic, Olivet College is pleased to administer a special emergency federal financial aid grant program for eligible students, the Olivet College American Rescue Plan Grant Program. This funding was made available through the Federal Higher Education Emergency Relief Fund III (HEERF III) and authorized by the American Rescue Plan of 2021 (ARP).

According to U.S. Department of Education guidelines, the emergency financial aid grants funded under this program are intended to be used to ensure that learning continues for college students. Funds may be used for education-related and living expenses, including tuition, technology, food, housing, health care (including mental health care), childcare and other needs. In addition, ARP Funds are particularly targeted at providing an opportunity to receive a financial aid adjustment for financial aid applicants who have experienced the recent unemployment of a family member or themselves if they are an independent student.

The federal fund guidelines direct all awarding institutions (including Olivet College) to prioritize awards to students with exceptional need, such as students who receive Pell Grants or who have experienced extraordinary financial circumstances due to the pandemic. Grant award amounts will be based on the most recent financial information we have on file for you, including the most recent FAFSA or other documentation of financial need, including responses on this form.
